PRODUCER AGREEMENT*

1. PRODUCER does not have any right or authority to bind or accept any risk on behalf of **J.J. Farber-Lottman Co., Inc.** or its principals, without first obtaining authority from a duly authorized representative of **J.J. Farber-Lottman Co., Inc.**
2. PRODUCER agrees to refund to **J.J. Farber-Lottman Co., Inc.**, commissions on any unearned premiums caused by cancellation or reduced premium, at the same rate at which such commissions were originally allowed PRODUCER.
3. In all cases where fees, service charges, and/or inspection report expenses are charged to PRODUCER by **J.J. Farber-Lottman Co., Inc.** such charges are fully earned on binding and the PRODUCER agrees to promptly pay such charges in full to **J.J. Farber-Lottman Co., Inc.**
4. It is the sole responsibility of the PRODUCER to guarantee prompt payment of all earned premiums to **J.J. Farber-Lottman Co., Inc.** and that any credit extended by PRODUCER to the insured or to any others will be at the PRODUCER'S sole risk and expense.
5. Renewal policies are not necessarily automatic. Policies that ARE NOT automatic must be negotiated and ordered from **J.J. Farber-Lottman Co., Inc.** by PRODUCER prior to the expiration.
6. This agreement shall be governed and construed in accordance with the laws of the State of New York/New Jersey and any alteration or modification of this agreement must be in writing and separately signed by respectful parties involved is such an alteration or modification.
7. This contract reflects the entire agreement between the parties and sets forth all of their rights and obligations to one another.
8. This agreement may not be amended, modified or changed, except in writing, separately signed by both parties.
